Dear Dr. Gottlieb

AllTrials wrote to you in February 2018 about the launch of the FDAAA TrialsTracker, developed by the EBM Datalab at the University of Oxford. This publicly accessible website checks compliance with the results reporting requirements of the FDAAA 2007 and HHS regulations 42 CFR Part 11 (the Final Rule). It then displays all the individual trials that have breached. We said that we would write to you every week with a list of the trials that have breached their reporting requirements, and a rolling total of the fines that these trials should incur.

The tracker has been live at <https://fdaaa.trialstracker.net/> for 41 weeks. As of 12pm GMT today, 1939 trials on ClinicalTrials.gov are assessed as due to report results. 1177 of those have reported results. That is a reporting rate of 60.7%. The potential fines the FDA could have collected is now estimated at \$1,208,641,634. 762 trials have not reported results. Those trials are listed below.
